

PROJECT SUMMER CONTEST  
“MY BOOKS SUMMER CONTEST”

Official Rules:

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** You can enter the Project Summer Contest (the “Contest”) in two ways only: Post a description of you plan to inspire summer reading among kids during the summer months on Facebook at [www.facebook.com/scholasticteachers](http://www.facebook.com/scholasticteachers), or on the Scholastic On Our Minds Blog. By entering this Contest, you acknowledge that this information is being submitted to Scholastic Inc. (“Sponsor”) and not to Facebook or Pages. One entry per person. Contest opens for entry at 7:00am EST on Sunday, April 12, 2015 and all entries must be received by 11:59p.m. EST on Monday, May 11, 2015. Released Parties (as defined below) assume no responsibility for (a) lost, misdirected, damaged, stolen, illegible, failed, incomplete, inaccurate, garbled, delayed or late entries, emails or mail; (b) telephone, electronic, program, network, Internet, or computer delays, deletions, interruptions or other failures or errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise of any kind; or (c) any human error that may occur in the processing of any entry or otherwise in the administration of this Contest, nor are they responsible for any theft or destruction or unauthorized access to, or alteration of, entries, whether caused by the sender or any of the equipment or programming associated with or utilized in this Contest. Proof of online submission of the entry does not constitute proof of delivery. In the event of a dispute regarding the identity of a person submitting an entry, the entry will be deemed to be submitted by the Authorized Account Holder of the e-mail address at the time of entry. “Authorized Account Holder” is defined as the natural person who is assigned the e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries become the property of Sponsor and will not be acknowledged or returned.

2. Contest open to legal residents of the 50 United States and the District of Columbia age 18 and older as of April 12, 2015 who work in or volunteer for youth programming and/or education. Employees of Sponsor, its affiliates, subsidiaries, and their respective advertising, promotion, and fulfillment agencies (collectively, the “Related Entities”), and the immediate families (spouse and parents, children, siblings and their respective spouses, regardless of where they reside) and household members of each, whether or not related, are not eligible to enter or win. By submitting an entry, entrant represents and warrants that the entry is his/her original work, he/she has all rights necessary to submit the entry, that the entry has not been previously published and does not infringe upon the rights of any third party and no further permission, clearance or payments are necessary for submission or use of the entry as contemplated hereunder. Subject to all applicable federal, state and local laws. Contest is void where prohibited or restricted by law.

3. Three (3) Grand Prize winners will be chosen. All eligible entries received will be judged based on the following weighted criteria: thirty percent (30%) on academic alignment, thirty percent (30%) on community connectivity, twenty five percent (25%) on student engagement and fifteen percent (15%) on innovation. Winners will be chosen by Sponsor. Winners will be notified on May 18, 2015. Sponsor reserves the right not to award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. Prize awards are subject to verification of eligibility and compliance with these Official Rules.

4. **Grand Prize:** Each of the three (3) Grand Prize Winners will receive seventy five (75) My Books Summer book packs. Each book pack shall contain five (5) books, five (5) activity sheets, a student journal and a program guide designed to fit a different reading level between PreK and 12<sup>th</sup> grade. Approximate retail value is \$2,600. Each winner will choose a grade level for which they would like to receive the book packs and these prizes will be sent to a school or non-profit educational organization of each winners’ choice, which shall be responsible for payment of any and all federal, state or other tax liabilities (including income taxes) on any prize received as well as any costs and expenses associated with prize acceptance and use of prize not specified herein as being provided.

Sponsor and Related Entities shall not be liable for unsuccessful efforts to notify any winner. If any winner does not meet qualification criteria or cannot be reached, Sponsor reserves the right to select an alternate winner. After Sponsor's attempt to award the prize three (3) times, Sponsor may decide that any unclaimed prize will not be awarded. Winners will be notified by email or postal mail using the contact information provided to Sponsor.

5. Entrant agrees that Released Parties are not responsible for any unauthorized use of entries by third parties. Released Parties do not guarantee the posting of any entry. Entrants agree that they will not use the entry for any other purpose, including, without limitation, posting the entry to any online social networks, without the express consent of Sponsor in each instance. By submitting an entry, each entrant agrees Sponsor shall own the entry submitted (including all rights embodied therein) and that it and its designees may exploit, edit, modify, and distribute the entry and all elements of such entry, in any and all media now known or hereafter devised, in any manner, together with other materials, worldwide, in perpetuity without compensation, permission or notification to entrant or any third party. Entrants represent and warrant that they have all rights necessary to submit their entry, their entry does not infringe upon the rights of any third party, and no further permission, clearance of payments are necessary for submission or use of the entry as contemplated hereunder.

6. Prize is non-transferable not returnable, and cannot be sold or redeemed for cash. No prize substitution except by Sponsor in case of unavailability, in which case a prize of equal or greater value will be awarded. Potential winners will be notified by email or postal mail using the contact information provided to Sponsor at time of entry. Potential winners may be required to sign and return an affidavit of eligibility and liability/publicity release (unless prohibited) within five (5) days of notification attempt or, at Sponsor's discretion, an alternate winner will be selected

7. By entering, winners agrees that Sponsor, the Related Entities, Facebook, Pages and their respective officers, directors, agents, and employees (collectively, "Released Parties") will have no liability or responsibility for any injuries, losses, or damages of any kind, including but not limited to death, injuries, damages or losses to persons and property which may be sustained in connection with this Contest, the receipt, ownership or use of the prize or while preparing for, participating in, and/or traveling to any prize-related activity, or accepting, possessing, using or misusing any prize, and they will be held harmless against any claims of liability arising directly or indirectly from the prizes awarded. Released Parties are not responsible if any prize cannot be awarded or enjoyed due to travel cancellations, delays or interruption due to weather, natural disaster, acts of war or terrorism or other causes beyond Sponsor's reasonable control.

If the administration or integrity of the Contest is compromised or corrupted at any time, the Sponsor reserves the right to modify, suspend or cancel the Contest and, if terminated, at Sponsor's discretion, award the prizes from among all non-suspect, eligible entries received up to time of such action using the judging procedure outlined above. Released Parties shall not be liable for any injury or damage to an entrant's or any other person's computer related to or resulting from entering the Contest. Any person attempting to defraud or in any way tamper with this Contest will be ineligible for prizes.
